What a challenging year it has been! The divisiveness of the election, a hobbled economy, crippling unemployment, wildfires, floods, droughts and, of course, COVID. Everyone has been challenged at home and at work.

But we are resilient, and we find ways to adjust and tolerate and survive, even thrive. Our economy may be temporarily shrinking, but I am convinced that we are growing as compassionate human beings. We keep finding ways to work together and help each other.

MoKidsChance faced challenges this year as well. With your help, however, our fundraisers were successful, the energy of our volunteers was intense, the money we raised was surprisingly high, and we were again able to provide scholarships to nearly 40 students in need.

That means that much of the money they raised does not show up in this year's report, but will show up next year instead. Looked at as a calendar year, MoKidsChance had a healthy year and did *not* spend more than it took in.
